Color Profile:	sRGB or Adobe 1998		
Named as:	Image Title.jpg (Sample: New York at Sunrise.jpg)		
	Must be exact name of Print		
Saved as:	JPG, quality 10		
Total File Size:	Not to exceed 3.5 MB		
4 Categories:	Portrait * Weddings/Events * Illustrative * Artistic (<u>NEW</u> !)		
Max Entries:	Send up to 6 images!!		

Do not use your own name in the file. Remove any keywords added to the EXIF data.

REMINDER!

In an email, identify each submission **EXACTLY** as follows: **Last Name,First Name,TITLE,Category** Sample: Smith,Jennifer,NEW YORK AT SUNRISE,Illustrative (no space after commas) Repeat for each submission. Send images as attachments to the email. Subject format for email - Month Year Print Comp (Sample: Sep 2019 Print Comp)

In the news, after years of work on the part of the PPA, the "Case Act" passed both houses of Congress on December 21. This legislation creates a small claims process for creators whose work is infringed upon. Prior to this, if someone copied your images and used them for their own purposes; your only recourse was to sue in Federal Court. The legal expenses of doing so could run upwards of \$30,000 and made it virtually impossible for a small business owner to protect his/her works. With the passage of this legislation, there is now a small claims process for creators whose work is infringed upon.
